

The University of Texas Midshipman Foundation Trust Fund Financial Report

The "Trust Fund", that we so often refer to, is actually the **University of Texas Midshipman Foundation** [UTMF for short]. A little background: UTMF was established by the Board of Directors, MIDSHIPMANS Foundation, to receive and administer gifts from Alumni with the express purpose to provide scholarship assistance to midshipmen at UT. The goal of UTMF is to reach a \$100,000 corpus and to give deserving scholarship grants/awards while working to that goal. UTMF directors are appointed by the Board of Directors for a three year term. The current directors are as follows:

Kirk Cansler, 1945 - Chairman

Will McCann, 1961 - Vice Chairman

Weldon Koenig, 1962 - Secretary

UTMF directors may only expend funds other than scholarship/awards for necessary expenses to administer the fund and to request contributions. This is done through the Board of Directors' Treasurer with reimbursement to the Board by UTMF (i.e. mailing costs, award purchase). The Board, with operating funds, provides for plaque purchase and engraving when donors reach specific levels. That preserves the corpus. If you

Treasurer's Report on the Alumni Operating Fund Status for 1996

1996 was a good year for the Operating Fund, but not a great year. We received contributions from only eighty-six (86) of the more than nine hundred (900) individuals on the mailing list of graduates from the UT NROTC commissioning programs. Many of these were very generous, which raised the average contribution to over \$43.00 per contributor. Total contributions were \$3,730.00. Unfortunately, this was not enough to cover the yearly expenses from current contributions.

Your generosity to the operating fund is appreciated by the UT Midshipmen, the Professor of Naval Science and the Board. These funds provide the assistance to the unit for items other than scholarships, and they provide the funds necessary to publish the newsletter, directory and other board approved items necessary for continued operations of the alumni foundation.

Every alumni (over 900) receives the Newsletter. However, expenses have increased for the directory publishing and mailing. Therefore, the directory is sent only to those alumni giving currently to the Operating Fund and to the scholarship trust.

If you have not previously contributed to the Operating Fund, please consider doing so. If you are currently contributing, how about taking it up a notch to the next level of support? Current suggested levels are \$25 Regular, \$50 Sustaining and \$75, or more, Patron. Gifts to the Operating Fund may be sent to me throughout the year at the Newsletter return address.

Lastly, the Board tries to transfer some portion of surplus moneys in the fund at the end of the year into the scholarship trust. We were not able to transfer any moneys this past year.


Bruce Byron holds the "All Hands" business meeting while Alumni want him to get to the socializing!

In Memoriam

Edwin M. Gale, 1944 - October 17, 1996

Leslie A. Sanders, 1958 - May 21, 1995

Edwin M. Gale, 1944, was a long time member and supporter of the MIDSHIPMANS Foundation. He was a \$2,500 level donor to the scholarship trust fund and established many educational chairs at the University. Edwin was commissioned Ensign in 1944 and served in the D Day invasion of Europe during WW II. He was especially proud of his naval service and his many life long friends he had made in the Navy. In 1976 he was honored as a Distinguished Alumnus of the College of Business Administration and in 1979 he was named to the Development Board at UTMB. He was owner of the Warren Refrigerator Company in Beaumont, Texas. Edwin is survived by his wife, Becky, daughters, granddaughters and many friends.

CDR Leslie A. Sanders, USN

Retired, 1958, was a career naval aviator, who had flown over 250 combat missions in Vietnam. He was said to be the most highly decorated Vietnam era pilot in the seven county area around his home town of Seadrift, Texas. Among his awards was the Distinguished Flying Cross. He was the commanding officer of a jet attack squadron and the deputy director of the only fighter aircraft/helicopter test pilot school in the US. His duties included the training of future space shuttle commanders. Upon retirement, he returned to Seadrift and was active in local civic activities. He was nominated to serve on the Texas Parks and Wildlife Commission and Wildlife Seafood Advisory Committee. He was later employed as an engineer by Formosa. Leslie is survived by his wife, Dollie, daughters, sons, granddaughter, brothers and sisters.




