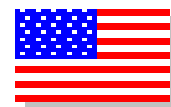

BOARD OF DIRECTORS CHANGE FACE

The Alumni attending the Annual Business meeting held during the Reunion Weekend in October elected three new alumni to the Board of Directors of the Midshipmans Foundation. They are John Allman, 1966, John Engstrom, 1966, and Robert Collins, 1968. Dr. Jim Adkins, 1955, elected not to seek another full term, while Keys Curry, Jr. and John Hitchcock elected to move to the "Presidents Emeritus" ex officio positions previously established by the board. These three "former Directors" have been on the Board since the forming of the present Foundation and received a "well done" from the Alumni. John Allman will serve a full three year term while John Engstrom and Robert Collins will serve the unexpired terms of Keys and John H. of two and one years respectively. The new Directors have already expressed a strong desire to be pro active Directors.

Max Miller, 1957, Gary Schoen, 1966, and Rodney Koenig, 1962, were reelected to another three year term as Foundation Directors. The Board consists of twelve Directors, four being elected/reelected every year at the Annual Business Meeting by the Alumni.

Will McCann, 1961, was reelected for another three year term as a Trustee of the University of Texas Midshipman Foundation (the scholarship trust fund) by the Board.

Also, elected by the Board in executive session were Foundation Officers for the next two years. Bill Docekal, 1965, was elected President. Bob Gartner, 1965, was reelected Treasurer and Gary Schoen, 1966, was reelected Secretary. Rodney Koenig, 1962, the current Vice President has one year left on his two year term. The Assistant Treasurer/Secretary position was not filled at that time.

BOARD SELECTS OCTOBER 23, 1999 FOR THE NEXT REUNION!

The Board of Directors have gone "high tech" and selected the date for the next Reunion as October 23, 1999 by internet e-mail vote. This is the UT vs. Nebraska game date. Max Miller has volunteered to head the Reunion Committee and has already secured the Outdoor Pavilion at Camp Mabry in Austin for the evening dinner. The location is covered, with seating in place and is convenient for the Alumni. It should be a suitable change from the American Legion Hall on Town Lake which has been our dinner location for the past several reunions. Board members will also discuss at the 30 January 1999 Board meeting having the Reunion at 18 or 24 month intervals to enable more people to come and to set a summer time for some years. Plan to come this year as future Reunions may be farther apart.

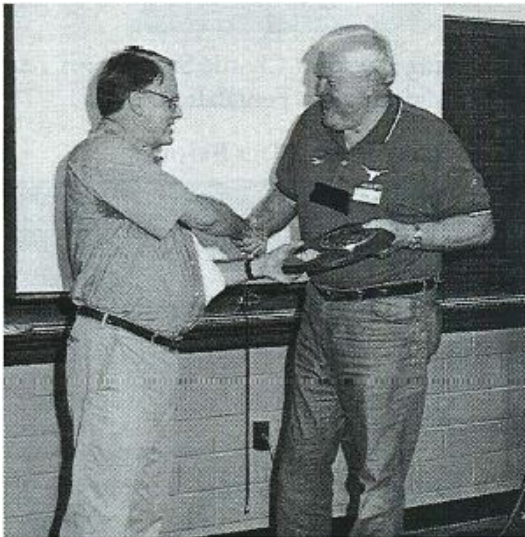

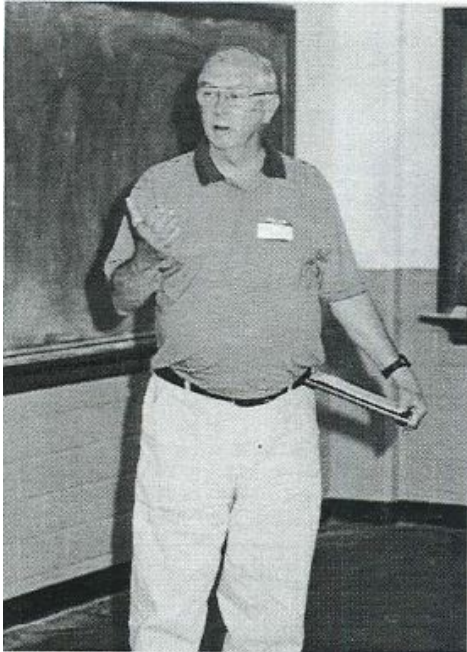

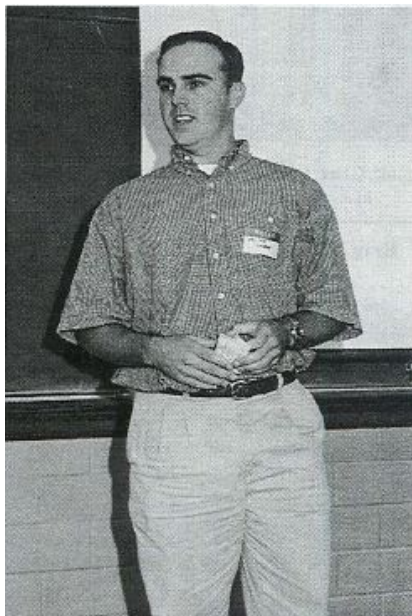
